E-tender notice for 26<sup>th</sup> Mango Mela at Yadavindra Gardens, Pinjore was released in the newspapers for quoting the rates of hiring of agency for providing tentage, furniture and fabrication of stalls alongwith generator sets in the mango mela to be held on 8<sup>th</sup> & 9<sup>th</sup> July, 2017 at Yadavindra Gardens, Pinjore. In response to our tender your firm had quoted the rates.

Accordingly supply order no. HTC-17/Fur/Spl.1 dated 5.7.2017 was issued in the favour of your firm i.e. M/s Total Solution, SCO 64, Phase 3B2, Mohali being the L-1 but you refused to receive the same and also demanded post dated cheques. Even you lifted your material from the site on the night of 5<sup>th</sup> - 6<sup>th</sup> July, 2018.

Since your firm has not started the work and ditched HTC at the last movement and tried to jeopardize the 26<sup>th</sup> Mango Mela to be held from 8<sup>th</sup> & 9<sup>th</sup> July, 2017 at Yadavindra Gardens, Pinjore by refusing to do the work and also tried to spoil the image of HTC and Haryana Government. As per clause 5 of the General Terms & Conditions of the tender document, the EMD alongwith security deposited vide DD No. 073053 dated 30.6.2017 of UCO Bank has, therefore, been forfeited besides blacklisting your firm for future ventures in Haryana Tourism Corporation .
